# **Health Service Committee Report**

#### 2013 Rates & Benefits Almost Ready To Go

The June 14 HSS Rates and Benefits Committee meeting (chaired by Karen Breslin) again preceded the regular HSS Board meeting (chaired by Claire Zvanski). Many of the items for 2013 rates and benefits had already been approved at prior meetings and others were approved at what originally was expected to be the final meeting before the package was sent to the Board of Supervisors for final approval. However, one item remained for a special meeting in late June or early July.

Items resolved at previous meetings included retiree dental plans, with rates guaranteed at least through the end of the 2013 plan year (DeltaCare HMO until Dec. 31, 2013, and Delta PPO

#### **Entitlement or Benefit**

I found this in the December 2011 edition of the American Association of Retired Persons (AARP) magazine. You might find it interesting. In a section of the magazine called ASK LEE (the AARP President) the question was raised:

**9:** What does it mean to call Social Security and Medicare "entitlement" programs?

**A:** "The truth is, Social Security and Medicare should be called "earned benefits" not "entitlement" programs. You don't get these benefits as a birthright. They are based upon a lifetime of payroll contributions from your work (as well as, for Medicare, your ongoing premium payments).

The word "entitlement" makes these benefits sound like something that you did not earn and don't deserve. Maybe that is why lawmakers who demand cuts in Medicare and Social Security use the term so often.

We must never forget the beneficial impact these benefits have had on the quality of life for older Americans and people with disabilities. They (Medicare and Social Security) have reduced poverty, enabled better health, and played a vital role in protecting the health and economic security not only of the most vulnerable but also America's middle class.

and Pacific Union HMO through June 30, 2014). Rates for the VSP vision plan are also guaranteed through June 30, 2014. And the Board unanimously approved a new prescription drug plan for Medicare retirees in City Plan, that would result in estimated savings of \$2,325,000 a year. More than 95% of current prescriptions would be covered at the same, or lower, rates.

Items approved at this meeting included a slightly revised 10-county survey that better fits the new calendar plan year, plus final City Plan rates for active and retired HSS members. City Plan increases for early retirees are from roughly 1.5 to 2.5% and for Medicare retirees rates will be the same or lower. For the approved Kaiser plan, early retirees rates will increase 1.2% and Medicare retiree rates 0%.

The one unresolved part of the 2013 HSS health plan package involved Blue Shield, whose rates and funding must be approved at another special rates and benefits meeting before the package can be sent to the Board of Supervisors. As it has in the past, Blue Shield came in with an unacceptably steep proposed rate increase and several—probably unacceptable—ideas for changing the plan structure.

#### **Regular HSS Board Topics**

HSS Director Catherine Dodd reported on several aspects of HSS activity, including the effects of the probable launch of the new eMerge technology program before the end of June. The July HSS meeting was cancelled, in part to allow HSS staff more time to prepare for Open Enrollment, which is in October this year. Also, this summer is a good time to get acquainted with the HSS Web site, www.myhss.org.

#### June 13 SFERS Official Announcement— Retirement Board Commissioner Election

As mandated by CCSF Charter and Administrative Code, a special election will take place to fill the vacancy of incumbent (active, SFPD) Commissioner *Al Casciato*, whose retirement is effective June 30, 2012. Following are special features and timetable of the election:

- *Term of Office:* From Sept. 20, 2012 (certification date), to Feb. 20, 2015.
- Eligibles: Only active CCSF employees may run because Charter 12.100 requires that only one retiree may serve on the Board at one time, and Herb Meiberger, CFA, now fills the retiree seat. However, all active and retired SFERS members may vote!
- Nominations: Monday, June 25 through Friday, July 27, 5 p.m. SFERS will verify nominations and send them to the Department of Elections no later than July 30. (Do you know a viable candidate? Tell them to contact SFERS' Norm Nickens immediately at 30 Van Ness Ave., Suite #3000, SF CA 94102, (415) 487-7025.)
- Election: Ballots mailed. The Department of Elections will mail ballots no later than Aug. 23, 2012. Watch your mailbox! Contact the Department of Elections, City Hall, 1 Dr. Carlton B. Goodlett Place, Room 48, SF CA 94102, (415) 554-4375, if you don't receive your ballot in a timely manner or if you have any other ballot-related questions.

**Ballot features:** Follow the ballot's instructions carefully. Please be sure to sign the out-

side of the return envelope; if not, your ballot won't be counted!

Ballot period: Sept. 4 through Sept. 18, 2012, 5 p.m. Ballots must be received at the Dept of Elections by the Sept. 18 deadline.

*Ballot count:* Wednesday, Sep.19, 2012, starting at 8 a.m., at Department of Elections.

 Winner/Commencement of Term: No later than Thursday, Sept. 20, 2012, the Dept of Elections will certify the winner, who will then be seated on the SFERS Board.

It's unfortunate that there isn't a separate August *Bulletin* because we haven't yet been able to identify the candidates. Also, no general membership meeting in August means no RECCSF official endorsement. Anyway, there will be candidate campaign materials in August. Above all, be sure to get your ballot in by the Sept. 18 deadline.

#### Other Points of Interest:

At its June 13 meeting, the SFERS Board elected *Wendy Paskin-Jordan*, mayoral appointee, as president, and *Joe Driscoll* (active, SFFD) employee representative, as vice president, for the coming year. Commissioner Meiberger noted that miscellaneous representatives have not been elected to officers' posts in the past twelve years.

Preliminary reported results for the FY 2011/12, 11 months ended May 31, 2012, show Plan value of \$14.9B, down from \$15.7B as of April 30, 2012, and FYTD (fiscal year to-date) earnings of minus 0.90%. As expected, the biggest "hits" this last month were international and US equities. More analysis to come in our September report!

The search for the new deputy director of investments is coming to an end; we should know the successful candidate in July.

#### POB Lawsuit—Correcting Two Of The SF Weekly's Errors

A column in the June 13 issue of the *SF Weekly* badly mischaracterized the nature and purpose of the POB lawsuit that has been brought on behalf of city employees who retired from a wide range of city positions. Although the writer did speak with POB Chair Larry Barsetti and included some accurate quotes about the purpose of the POB lawsuit, his column also included several obvious inaccuracies.

For example, the writer wrongly described the POB lawsuit about Proposition C's elimination of our supplemental COLA as a fight between "old cops" and "new cops," rather than a lawsuit brought by POB on behalf all city retirees. The writer also said the city controller stated in the voters' handbook that eliminating the supplemental COLA would save the city \$300 million. In fact, the controller said it was not possible to determine how much would be saved by the proposed change.

#### San Jose, San Diego – And Maybe Los Angeles?

As you know, on June 6 voters in San Jose and San Diego approved the idea of cutting pensions—and reducing health care—for new hires and making some changes for current employees. But the two cities' methods are different. In San Jose, the defined benefit plan

would continue, but current employees' payments would remain at 25% of pension costs, while new hires would pay 50%. And retirement age for new civilian employees would be raised from 60 to 65.

In San Diego, new employees would be placed in a 401(k)-style plan, a defined *contribution* plan, rather than the current defined *benefit* plan. In both cities, employee unions have already gone to court to block the changes.

In Los Angeles, Mayor Antonio Villaraigosa has said he's preparing to take public pension reform directly to voters next year if the LA city council doesn't pass it.

So far, pension reform efforts around the state are not focused on current retirees.

# Why Voting for Our Elected Retirement Board Commissioners is Important!

Some of us might think, "The charter says that the city must pay my pension every month, and, if inflation permits, my "basic" cost of living (COLA) too. So, why should I care whether or not we have elected commissioners on the Retirement Board?"

The most important reason: Employee-elected pension Board representatives ensure that the fund does what it's supposed to do: see that our money is invested prudently for the exclusive benefit of the plan beneficiaries. That's what we have at SFERS. But, consider what might happen if *only* political appointees were Board members. The door would be open to special interests, such as aggressive hedge fund managers, real estate barons, short-sighted business gurus—in a word, folks who love our money and don't care about us.

In fact, one recent example of the above comes to mind: a southern state public pension plan with only one elected board member, all others being special interest reps. The plan's returns ballooned shortly before the 2008 recession. Since then: big market reverses and the plan is in serious financial trouble. (FYI: The investment manager who engineered the state's high-flying portfolio is no longer with the pension plan. He's now employed by a hedge fund. He drives a Lamborghini.)

Please read the SFERS Board commissioner candidates' campaign materials, watch for your ballot around or shortly after Aug. 23, and mail your ballot in well before the Sept. 18 deadline!
