Last-Minute Tax Tips

We've all had years when our taxes come down to the wire. If this is one of those years for you, follow these last-minute tax tips from the Internal Revenue Service (IRS) to ensure that your taxes are complete—and accurate—when April 15 rolls around:

- File online. Save time and postage by e-filing your Form 1040. The process is safe, secure and simple. Visit IRS.gov to get started.
- Double-check the important stuff. When you're in a rush, it's easy to make mistakes on important information. Make sure all identification numbers (such as Social Security numbers), refunds, or balance amounts and tax-table figures are correct.
- Sign on the dotted line. Don't forget to sign and date your return. If you file a joint return, you and your spouse both must sign it, even if only one of you had income. Additionally, paid tax preparers also must sign.
- Pay online. If you owe money this year, make your payments on time by sending them electronically. The IRS allows taxpayers to authorize electronic funds withdrawals or pay via debit or credit card.
- Request an extension. If you know your taxes will be late, request an extension to file. You must have either requested an extension or filed your return by the tax deadline. The IRS reminds taxpayers that an extension to file is not an extension

Health Service Committee Report

You have an opportunity to name the HSS Wellness program! Words that rhyme are *always* best and most memorable. While the staff recommendation is "stay strong, live long," it was agreed that all members should be involved in this effort. Send your suggestions to HSS, attn: Rosemary.

Rates and Benefits: The 10-county survey was presented, increasing less than previous survey trends. The economy, plus efforts to provide lower cost health benefits to public employees, was cited as the reason. The monthly contribution for 2015 will be \$567.80, which is 1.46% above the current \$559.65.

Determining rates for 2015 when 2014 has just begun is a challenge. But, good experience (no high claims) seems to be continuing in all plans, so it is anticipated that rates will remain stable. One should know that—unlike the other two plans—Kaiser information has a three-month lag, so updated data could impact premium rates in time. The Accountable Care Or-

ganizations in Blue Shield seem to be very successful, and are keeping claim costs low, which translate into lower premiums.

Vision plan rates are guaranteed through December, 2015. At this point, plans to offer an increased benefit at an additional cost remain stalled, because of the limitations of the eMerge system. The retiree dental survey is scheduled to be sent at the end of March.

A very extensive membership demographics summary was presented at the meeting. The System covers nearly 110,000 lives, which include about 35,000 retiree lives. 92% reside in the seven Bay Area counties. Actives are 58%, while retirees are 42%, and 55% of dependents are children under age 26. The average age of retirees is now 71.34 years. Retirees live in nearly every state in the nation, with 51 living outside the US. 94% live in California.

The Wellness Center is open for business on the first floor at 1145 Market St. "Lunch and learn" sessions, plus EAP services, are underway. HSS moved its offices to the Third Floor on March 14. Don't forget to send your wellness program slogan suggestions to Rosemary at HSS!

Retirement Committee Report

Current Plan performance and a look ahead

Reported preliminary results as of 2/28/2014 are: Plan value, \$18.85B—yet another all-time high—and eight-month fiscal year-to-date (FYTD) earnings, 13.22%. These results are indeed impressive, but an over-arching question remains: Will the Plan be able to attain the 7.58% per year estimated earnings level in the future? To meet that challenge, new Chief Investment Officer (CIO) Bill Coaker is recommending an enhanced program—called "active share"—to capture excess earnings above standard benchmark returns. Successful in other jurisdictions, the program emphasizes in-depth, on-site, due diligence and advanced technology-based research by dedicated staff. SFERS anticipates the additional needs—especially augmented investment staff and research materials—and includes them in its FY 2014/15 budget requests. In addition, the CIO recommends selling bonds and investing 10%-15% of assets in hedge funds.

Actuarial matters: FY 2014/15 City contribution rate; funding ratios, 7/1/2013 vs.7/1/2012

At its 3/12/2014 meeting, the SFERS Board accepted consulting actuary, Cheiron's, July 1, 2013 Actuarial Valuation's recommended City contribution rate for FY 2014/15: 26.76%. After employees' pickup (thanks to 2011-passed Proposition C) the City's effective rate is reduced to 23.18%, giving the City's estimated FY 2014/15 out-of-pocket cost of approximately \$610M. We're happy to report that the City's FY 2014/15 total rate is about 1.5% less than actuaries projected in 7/1/2012.

Funding ratio comparison follows:

	7/1/2013	7/1/2012
Market value	84.1%	78.9%
Actuarial value	80.6%	82.6%

Notice: For the first time since 2007, the 7/1/2013 market value of assets exceeds the actuarial value, meaning that earnings are improving. However, the 100% market value of assets ratio still eludes us. (Say a prayer for POB's lawsuit!)

Other Items of Interest

- At a special-called meeting on 2/19/2014, the Board unanimously agreed to apply *Social Investment Policies and Procedures*, Level I, to fossil fuel investment (holdings worth \$500M+ within SFERS' total existing portfolio). Level I limits expression of social concerns to shareholder voting. The Board also set a 60-day timeline for additional educational materials.
- The S.F. Board of Supervisors approved SFERS' relocation to 1145 Market Street! SFERS Executive Director **Jay Huish** says the move could take place as early as next August, but more likely in September or October.

Correction to the March 2014 Retirement Committee Report, Other Points of Interest, regarding the Retirees Health Care Trust Fund (RHCTF) Board

We apologize to the RHCTF Board, and to our readers, for an incorrect statement that the RHCTF Board had decided to invest its \$40M "alongside" SFERS' trust assets. RHCTF Board President Pauline A. Marx states the correct situation in a 3/11/2014 e-mail to **Jean Thomas** (author of that section of the report), as follows: "At the 1/28/2014 meeting of the RHCTF Board, the Board's advisor, Meketa Investment Group, presented four implementation options for investment of the Trust Fund. The Board discussed the options presented and asked Meketa to further analyze two of them: direct co-investment with San Francisco Employees' Retirement System, and investing through the California Employer's Retirement Benefit Trust. In either case, the RHCTF Board will continue to have fiduciary responsibility for the assets."

Earthquake Preparedness

On April 18, 2014 San Francisco will hold its annual 1906 Fire and Earthquake memorial. We should mark this occasion by reflecting on how we can protect ourselves in the event of another major earthquake (such as in 1906), and, most recently, the Loma Prieta earthquake in 1989. Preparation and planning can help save lives. Some suggestions are:

Before

- Prepare an emergency plan, conduct drills, and practice safety procedures.
- Keep emergency supplies on hand, and check the stock frequently.

During

- If you are indoors, stay inside and take cover under a sturdy table or desk.
- If you are outside, head for an open area away from falling debris.

After

- Check that everyone is safe, and inspect for damage.
- If the power goes out use battery operated flashlights—not candles.
- Have a portable radio handy for receiving public safety information.

Proposition C has dominated the work of POB; as the matter is in the appellate court, there's an opportunity to refocus our efforts and increase our visibility, both inside and outside City Hall. Hence, we are discussing a Six-Month Strategic Plan to increase the visibility of POB efforts in protecting our earned benefits while we work with our legal team and others to submit amicus briefs.

Writ of Mandate Update

The POB legal team has apprised the committee that they are continuing with their work on the opening brief addressing the appeal. The work is based on updating legal research of defining and refining the issues on appeal. For example, one of the issues decided against POB

is that legislative enactments are presumptively valid.

According to our attorney, while this statement is generally accurate, the court of appeal is authorized and required to exercise its independent review of legal issues, especially pension statutes, which are construed liberally in favor of pensioners. POB remains confident that we all will prevail in the appellate court.
