Health Service Committee Report

This was the final meeting for HSS Director Catherine Dodd. She made a wonderful parting speech, with specific reference to each commissioner and a review of her service to the system. It's very clear that she set a very high bar that will be challenging to match in the future.

The job description was adopted by the board so that the replacement search can commence. Assistant Director Mitchell Griggs was appointed as acting director.

- The 10-county survey is the charter-mandated offset for retiree rates. The average monthly contribution of \$649.17 for the 2018 plan year is 7.33% above \$604.84, the current 2017 plan year average. All counties had a change in contribution rates. (Please note that HSS has never diminished or eliminated benefits as done in other counties and CalPERS over the years.)
- In 2016, the federal Health Insurance Tax (HIT) was applied to the Blue Shield Flex Funded Plan, due to filing with the California Department of Managed Health Care (DMHC) as a fully-insured plan. Upon re-evaluation by the DMHC, flex-funded plans are being treated as not fully insured and therefore not required to pay the HIT tax. That decision resulted in an estimated refund to HSS by Blue Shield of \$9,934,909. It also means that under current law, even if there are changes in Washington, D.C., we will no longer be eligible for the HIT tax.

It was determined for benefit parity that:

- A one time sperm retrieval and

Retirement Committee Report

- The value of the fund as of Feb. 28, 2017 is \$21.5 billion, with the fiscal year rate of return at 8.23%. The valuation is reported gross of fees. U.S. equities have performed well but global equities have declined dramatically, so the final performance remains unknown.
- The SFERS remains in the top 10% of public plans nationally, in the top 5% within the last five years, and in the top 1% in the last three years for performance.
- Northern Trust (NTGI) has been removed from the "under review" list. In 2014, it received a subpoena from the SEC requesting information on its securities lending activities. As a result, investment staff placed NTGI under review. In November 2016, NTGI received a "no-action letter" from the SEC, which indicates that the matter is closed. No charges were made by the SEC.
- In October 2016, the board approved a change in custodians from Northern Trust to BNY Mellon. The legal teams at Mellon and SFERS, as well as the SFERS investment team, have worked to advance the transfer of data and set up accounts to have Mellon operational on July 1.
- Hedge fund returns as of Jan. 17 are 1.0 %. The next investment committee meeting will be May 23.
- At a staff retreat, a number of key points were made by Blackrock. In the past year or so, five of the 10 largest countries in the world have experienced a leadership change. Political decisions in the U.S. and elections in France, Germany, and elsewhere in Europe present in-

creased risks to markets. Brexit is still a risk about which the markets may be too complacent. There is significant mistrust toward politicians, CEOs, Wall Street, and the media. Emphasis from the Trump Administration will be on taxes, trade, regulation, infrastructure, and immigration. Corporate tax reform will have implications on importers and exporters, inflation, and the value of the dollar. Major infrastructure spending will lead to higher employment, deficits, inflation, and economic growth. Dynamics are changing from globalism to populism, stagnation to possible inflation, monetary to fiscal policy, and regulation to deregulation. Blackrock (SFERS hedge fund manager) is more constructive on returns in emerging markets (China and Europe) than they are in the U.S., and they expect very low single digit returns from U.S. stocks over the next 10 years.

- Callan Associates is the Deferred Compensation Plan's investment consultant. Its performance summary for the 2016 calendar year stated that the DC Plan was valued at \$2.9 billion on Dec. 31, 2016. Commissioner Driscoll indicated there is a task list for Callan Associates, but no date has been set for the next committee meeting.
- Each year, audited financial statements for the SFERS are prepared by outside auditors selected by the controller's office. Macias Gini & O'Connell LLP stated that their audit disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards* in considering SFERS' internal control and compliance.
- The 2017-2022 Strategic Plan was presented, but the board

could not agree on the elements presented. The item is continued to the next meeting. Working together, senior management staff has identified business risks, opportunities and needs for the department, and identified priority strategic goals and objectives designed to address them. The FY2017-18 department budget included both staff and other resources to address these goals and objectives for the strategic plan beginning in the coming year.

- Executive Director Jay Huish presented a request from Commissioner Makras for the April meeting for a fossil fuel and thermal coal investment report to cover the period from 2013 to the present.

sperm storage for up to 12 months per lifetime benefit would be added. Sperm retrieval and sperm storage are available to members for whom medical treatment will result in the member becoming infertile; it is not for members who are undergoing voluntary sterilization.

- Gender dysphoria benefits need conformity among plans. A more comprehensive review should be done and presented in April for final approval. The discussion focused on the definition or interpretation of "medical necessity."
- Simple Therapy, a program of personalized pain recovery performed 100% at home through videos and direct communication with a physical therapist, was presented for consideration. For retirees, the program reduces the fear of falling, increases confidence in independence, and contributes to avoiding bone fractures, hospitalization, surgery and rehabilitation.
- HSS Finance was recognized for its contribution to the Financial System Replacement Project (F\$P) for provid-

ing solutions for outreach to over 50,000 vendors that do business with the city. The solutions were implemented by the controller's office.

- Catherine Dodd has been meeting with DPH to have Zuckerberg SFGH added as a network hospital for both Blue Shield and UHC.
- The HSS adopted an investment policy. This won't impact how the fund is managed, but the practices are now quantified in a policy.

Managing Your Checking Account

When you use your debit card or write a check, do you know if you have enough money in your checking account to cover the transaction? Not knowing can cost you. If you write a check for more than your account balance and do not have overdraft privileges, the check will bounce and you can be charged a nonsufficient funds fee. If you can overdraw, but do not have overdraft protection, you can be charged an overdraft fee for every

transaction you make while you are in the red.

Following a few simple steps can help you avoid these expensive fees:

Check your account balance.

- If you know your account balance, you will know if you have enough money for a particular transaction. You can check it any time of the day by calling (415) 775-5377 or visiting *SanFranciscoFCU.com*. Don't forget to subtract from the balance the amount of any automatically paid bills that will be deducted before your next deposit as well as outstanding checks.

Have a balanced budget.

- If you regularly find yourself short on cash and need to overdraw to pay for essentials, look for ways to reduce your spending and/or increase your

income. Overdrawing can provide immediate relief, but will probably only create more difficulties next month, when you face the same cash flow shortfall plus have to pay back the amount you overdraw.

Use overdraft protection.

- It is best to avoid overdrawing or bouncing checks completely, but if you feel that may be difficult, consider overdraft protection. It deducts or charges any amount you overdraw from a savings account, credit card, or line of credit linked to your account. At San Francisco Federal Credit Union, this service is free.

Protect Our Benefits

Protect Our Benefits is an organization whose goals are to enhance the dignity and quality of life of all San Francisco City and County retirees, and preserve their health and retirement benefits. The opinions are those of the writer.

On Thursday, March 9, 2017, the San Francisco Superior Court filed a writ of mandate in favor of the city that exempts the city from paying the pre-1996 retirees the supplemental COLA unless the retirement fund is fully funded or the charter is amended. SFERS will now have 60 days from the date of filing to file a notice to appeal.

POB is not a party to the suit: As it is CCSF vs. Retirement Board of SFERS, we can only act as an amicus curie (friend of the court). We have been apprised that, even in light of continued pressure from the city to discontinue with this litigation, the SFERS Board voted in favor of filing an appeal to have

this case heard by the appellate court.

It has always been our opinion that this case would ultimately be decided by the court of appeals, regardless of what happens in the superior court.

And the beat goes on. As to wondering about reimbursement for our attorney's fees, we have been told the process is moving through channels. City hall: "Oh, trust us, this is normal." Well, the next time you're late on a bill, fine, property taxes, parking ticket etc., you know that the city would be all over you. Just tell them: "The monies are just moving through channels."

And the beat goes on. POB has been informed of some "snafus" with the installment of United Health Care as health care provider. This was bound to happen when you have an enrollment of approximately 13,000 new members into the system. By and large, I hope it has worked out for most of the retirees. *If you are having problems, telephone the Health Service System at 1 (415) 554-1750 and be persistent. It is your*

health care and you pay for it. Remember, you are your best advocate.

And the beat goes on. POB has been informed that our new ERS Commissioner Al Casciato has "jumped into" his new post and is being very productive. Keep it up, Al, but always remember that POB will be watching.
