Health Service Committee Report

President Randy Scott was re-elected for another one-year term, along with Vice President Willie Lim. Commissioner Breslin made the motion to suspend the governance rules on successive terms for one year until June 2018. This was done to provide consistency on the board during the search and hiring process for a new executive director.

A representative from the executive search firm of Ralph Anderson Associates appeared before the HSS Board. She presented an example of the brochure that they would prepare for the job search, and described the process. She stated that the new police chief and the new head of the department of information technology were referred by her firm. She stated that the recruitment process would begin in earnest during July, and would probably be a 90-day process. President Scott stated there would also be individual meetings with constituent groups, and an open meeting in August for all constituent groups. She offered that the cost of housing in San Francisco is a

Retirement Committee Report

The first order of business was to elect a new board president and vice president. Police Sergeant Brian Stansbury was elected president, and mayoral appointee Wendy Paskin-Jordan was elected vice president.

- The fund earned 13.62% for the first eleven months of FY 2017-18. Public Equity returned 19.55%, with U.S. and international stocks earning 18.02% and 20.97%, respectively. Real assets earned 16.30%, while private equity returned 11.83%. Fixed income has only gained 3.45% over the last eleven months. These high returns bode well for payment of the supplemental COLA. If the fund earns more than the hurdle rate of 7.5%, and there are ample earnings to pay the supplemental COLA, retirees will be paid the 3.5% supplemental COLA. Stay tuned!
- According to Bill Coaker, CIO, the Hedge Fund (aka "absolute return") portfolio has returned 5.71% over the last seven months.
- Managing Director of Public Markets Bob Shaw left SFERS, effective

June 8, to become the chief investment officer in the city's treasurer's office. Another SFERS vacancy is the senior investment Officer for private equity since Glen Schwartz retired in April.

- Minutes from the board's retreat were not approved, as Commissioner Makras pointed out that the agenda reported to the public was not the agenda that was followed. So, the staff was directed to provide the actual agenda with actual minutes at the next meeting.
- Immediate Past President Supervisor Malia Cohen brought the United Nations-supported Principles for Responsible Investment (PRI) to the board for consideration. It is the largest global investor network dedicated to "responsible investment," with more than 1700 institutional investor and service provider signatories worldwide, representing over \$63 trillion in assets under management—over half of the world's investment assets. Priya Mathur, CalPERS Board member, was invited to speak on behalf of PRI. PRI is consistent with the SFERS Board's *Environmental, Social and Governance Values Statement*. Staff indicated it did not have time to review PRI to provide a recommendation, but supports the program for its enhancement of the SFERS engagement level. After much discussion, it was decided to await the staff review and consider the issue at the next meeting.
- Board advisor NEPC made recommendations for the as-

set class return assumptions and asset class mixes for the asset allocation modeling process. In this process, they will rename alternative investments to "private equity," absolute return to "alternative marketable investments," and include one new asset class, private debt. They state that the current actual mix has an expected return of 6.7%, with volatility ("standard deviation") of 13.4%. The goal is to achieve the highest expected Sharpe ratio, probability of a five-year return over 7.5%, and the highest probability of a positive return over the next five to seven years.

- The other major recommendation was to retain Parametric Portfolio Associates for cash securitization and rebalancing overlay services. How much and where cash lays is critical to paying pension benefits. It was pointed out that the contract would be for a full market cycle (one bear and one bull), which is approximately 10 years. The SFERS due diligence process began in early 2016 but the board has many more questions and is most concerned about the fees and the risks, especially given the longevity of the proposed contract.
- Clearly, the July meetings will be important. The Tuesday, July 11 special meeting, 9 a.m. to 12 p.m., will be the follow-up to the board retreat. The regular board meeting will be held on July 12.

big issue with candidates. (Department heads are required to live in the city.)

The rates and benefits process concluded with the following:

- confirmation of VSP rates approved last month with no change in COSTCO frame allowance;
- adoption of City Plan rates for actives and early retirees (pre-Medicare, below age 65);
- adoption of UHC Medicare Advantage (new City Plan) rates; and, for blended families, includes both Blue Shield Access Plus and Trio (no Sutter facilities) rates;
- Kaiser Senior Advantage retiree rates adopted;
- approval of Delta dental renewal rates including increasing the annual maximum benefit to \$1250 (up from \$1000);

- approval of Kaiser's proposal for coverage in Oregon, Washington and Hawaii. Every effort will be made to approximate comparable benefits in each state. The rates are still in negotiation, and they will be significantly higher than local Kaiser rates; and
- approval of Kaiser's enhanced fertility preservation benefit to more closely match same benefit in other plans. The proposal is awaiting approval of the CA Department of Managed Health Care.

The HSS board signed a resolution in support of California Senate Bill 538 hospital contracts that calls for rate transparency. The bill passed the assembly.

Starting in September, Simple Therapy will begin a pilot program. This is the plan that provides 24/7 access to a licensed physical therapist. Rates are still being negotiated (\$30 a month per member or less?).

There will be no Health Service Board meeting in July.

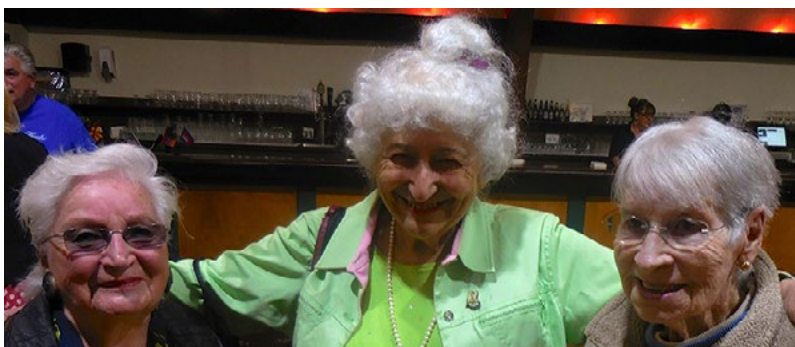

Protect Our Benefits

Protect Our Benefits is an organization whose goals are to enhance the dignity and quality of life of all San Francisco City and County retirees, and preserve their health and retirement benefits. The opinions are those of the writer.

CCSF vs. SFERS: On June 6, 2017, there was notice in the Register of Actions for the CCSF vs. SFERS case that a notice of appeal was filed. POB will remain vigilant and stay abreast of any further actions. We will also be keeping a keen eye on numerous other court cases now being heard for other municipalities regarding their pension benefits.

Fees for legal services: No change, still in the "process."

Investment Performance of the retirement fund: As per agenda item for the June 14, 2017 retirement board meeting: "For the quarter ended March 31, 2017, the retirement fund was valued at \$21 billion, providing a net of fees total return of +4.93% for the quarter, and a +10.15% for the fiscal year to date."

Health News: As far as "early retirees, pre-Medicare ages," it looks like they're going to take the hit, as usual. Kaiser has expanded coverage to Washington, Oregon and Hawaii. Dental and vision care have increased their benefits for a nominal fee. The search committee for a new director of the Health Service System will be

meeting with different unions and POB for input. When the booklets come out announcing the benefits for next year, be sure look at them and see which is best for you.

Remember, upon becoming Medicare-eligible a retired member *must* enroll in the Kaiser Permanente Senior Advantage plan, or the new City Plan offered by United Health Care. Members currently enrolled in Blue Shield who are becoming Medicare-eligible—and electing to enroll in the new City Plan—have the option of enrolling their non-Medicare dependents in the City Plan or allowing them to remain in Blue Shield until they become Medicare-eligible.

There have been talks lately from some of the State of California legislators with reference to passing a single payer system. It's just my just my opinion, but if this happens there go all the health insurance companies in the state, i.e. competition. The only thing that I can say is: "If you think it's expensive when you have to pay for it, wait and see how expensive it is when it's free."

As I mentioned in last month's article, POB is doing more organizing with sub-committees to address your concerns. We have made great inroads, especially since we have won the lawsuit. City hall, who before wouldn't even acknowledge our existence, now knows who we are. In future months, we will be talking to candidates for

the BOS, mayor, or anybody else who will listen to us in an effort to better represent you, the retirees.

Larry will be stepping down as chair of POB and will be replaced by Fred Sanchez. Larry will be vice chair as of July 1.

We want to express our appreciation for everything Larry has done for us. For the last six years, POB has had the good fortune of having a chairman who led us through this quagmire of politics, both dirty and clean. Larry was part of the first group to take on city hall, wherein he saw the unconstitutionality of Proposition C, and the impact it would have on the retirees. He has put in long hours attending numerous meetings, and is known for his tenacity and fairness, which has benefitted all of us. He has led POB to where we are now—and we're still growing.

The task before us is still large, but I am confident that the continued undertakings of POB will help chart a better future for the retirees, and the safeguarding of their health and retirement benefits.
