## Health Service Committee Report

President Randy Scott updated the status of the new executive director search. He acknowledged the special meeting with representatives of retiree organizations, including RECCSF. While the HSS Board will hold initial interviews with some candidates, the application process will remain open until finalists are chosen. A final decision isn't anticipated before November.

- AON Hewitt actuary Anil Kochhar has been the representative at board meetings and is noted for presenting actuarial reports in understandable language! He will be leaving AON Hewitt, so representatives attended to present a new team. Mike Clark will replace Anil to work with HSS staff and appear at board meetings. Former HSS Board Commissioner Scott Heldfond attended as part of the AON Hewitt team.
- Open enrollment preparation is the primary focus of all HSS staff. All are being trained to accurately present the Blue Shield Trio plan and the VSP Premier options.
- Blue Shield staff will be available in the office to help clarify the parameters of this new option. Retirees with split memberships (non-Medicare dependents remaining in Blue Shield) will be impacted and need to pay careful attention to this Blue Shield Trio option. Trio is the plan that excludes Sutter facilities and physicians. Some Brown and Toland physicians are also Sutter physicians and will be excluded. Members who already don't use Sutter facilities or physicians will be automatically en-

## Retirement Committee Report

This was an unusual Retirement Board meeting. Due to lack of a quorum, the board meeting was delayed several hours. When it began, the order of the agenda was altered, and, in the interest of time, only a few items were heard and the majority of the agenda was postponed to the next meeting.

- The Chief Investment Officer report was not heard, so the latest valuation of the fund was not given.
- Annual reports for divestment from tobacco and divestment from Sudan were presented and renewed for an additional year. An extensive list of restricted companies for tobacco and the specific divestment list for Sudan were submitted. The Sudan list included a significant list of oil companies.
- Actuarial Services Coordinator Janet Brazelton presented the Cheiron report of the supplemental COLA analysis of July 1, 2017. The report demonstrates that there are excess earnings as defined by (charter section) A8.526-3 of three and one-half percent (3.5%), less the basic COLA (2%) to the post '96 retirees. This means that **post '96 retirees will receive the 1.5% supplemental COLA as of July 1, 2017. Actual payment will be received in January or February 2018.** Since the Retirement System is not fully funded, no supplemental COLA can be paid to post Proposition C retirees (November, 2011) nor to members who retired before Nov. 6, 1996, due to the preliminary court injunction which is still in effect.
- The majority of the meeting was

spent reviewing and discussing the acceptance of the 2017 Asset/Liability Study and approval of the revised Asset Allocation Policy (hedge funds). Staff and board investment advisors NEPC and Cambridge recommended an “adjusted mix” of investment strategies that included increasing the absolute return (hedge funds) goal to 10%. The current policy limits hedge fund investments to 5% (\$1 billion). However, the board preferred an alternate recommendation that **increases hedge fund investments to 15%**. The advisors agreed with the board that the al-

ternate recommendation would probably improve returns over time—and was better than the proposed “adjusted mix”—but presented some higher risks. The vote was three to one (Bridges opposed) in favor of the alternate recommendation. Representatives present from miscellaneous employee unions and retirees spoke against the motion. This vote creates a significant change in investment goals for the future.

rolled in the Trio plan. Please read your open enrollment materials very carefully. Please note that there are some service exclusions from Dignity facilities and physicians (St Mary’s, St Francis, etc.)

- The **VSP Premier** option requires specific enrollment. It will be a private pay benefit so that you will be expected to pay separately. It’s an upgrade to provide annual replacement of glasses/contacts.
- If you lose your open enrollment form, you can download a new one from the [myhss.org](http://myhss.org) website.
- Plan representatives and HSS staff will be available at the **RECCSF Oct. 11 meeting** to help explain plan options and take your open enrollment changes.
- **Free senior flu shots** will be available for members and dependents at the Oct. 11 meeting. Bring your medical plan cards.
- The controller’s office will be performing a dependent verification audit of HSS membership. You might be asked to provide documentation verifying your marriage or domestic partnership. Most retirees already have documentation on file with HSS.

- Please let HSS know if you are receiving marketing calls from United Health Care. HSS does not allow solicitation of its membership by any vendor.
- The Oct. 12 meeting of the HSS board has been cancelled because of open enrollment. The November meeting will be a special educational meeting, with issues to be determined.

While many of us feel elated to hear there will be another supplemental COLA (to be paid in early 2018), we need to remember that our pre-96 colleagues will not see a supplemental COLA in their remaining lifetimes. We couldn't afford to take the lead in the Proposition C lawsuit, but we followed the progress of the lawsuit and a few RECCSF members serve

## **In Memoriam James T. Elliot 1924 – 2017**

Native San Franciscan Jim Elliot (nee Eliopoulos) was an RECCSF board member, Federation of Retired Union Members (FORUM) delegate to the SF Labor Council, member of Protect Our Benefits (POB), and member of the International Association of Machinists Local 1305 and the Peninsula Auto Machinists Local 1414 Retirees. He retired in 1985 after 37 years with the city, including 30 years as foreman at the Golden Gate Park maintenance

shop.

Jim was also known for his groundbreaking interview in the 1984 documentary, *The Times of Harvey Milk*. He was a lifelong Democrat, U.S Navy veteran, outspoken union leader, and civil rights activist. In the 1940s he was a regular at Winterland and Sutro Baths ice skating rinks. He joined the S.F. Silver Blades and was a champion speed skater and barrel jumper. He was an archery instructor, model railroad enthusiast, bicyclist, golfer, pilot (earned his license at age 63) and photographer. Life was his never-ending adventure.

Jim was married for 37 years and leaves three adult children. He will be greatly missed.

# Protect Yourself from “Skimming”

Technologically-savvy thieves have found ways to steal money without your wallet ever leaving your possession. One popular method is to attach a skimmer to a legitimate ATM or gas station terminal. When you insert your ATM or debit card, the skimmer reads your card information, and the PIN is captured with a hidden camera or keyboard overlay device. Then, they can put your information on a blank magnetic card or use it to shop online until your account is drained.

You don't have to avoid using your cards to keep your accounts safe. Just keep these tips in mind:

Before inserting your card, see if the card slot wiggles. If it does, there may be a skimmer on it. Use another terminal, and let your financial institution know.

Try using the same ATM for all of your transactions. You are more likely to notice if the machine has been tampered with if you are using a familiar one.

Cover the keypad when you enter your PIN. If a hidden camera is being used, this prevents the camera from

capturing it.

Always check your account statements for fraudulent activity. If you see any suspicious charges, notify your financial institution immediately.

# Protect Our Benefits

*Protect Our Benefits is an organization whose goals are to enhance the dignity and quality of life of all San Francisco City and County retirees, and preserve their health and retirement benefits. The opinions are those of the writer.*

## SFERS v. CCSF update (pre-1996 retirees)

On July 28, 2017, SFERS filed their opening brief with the appellant court. The City and County of San Francisco requested a 60-day extension to file its response, and their brief is now due Oct. 28, or sooner. SFERS will then file a reply brief. The court of appeals can then schedule oral arguments—probably after the first of the year—with a decision to be determined after that.

Core questions: Did the San Francisco voters intend to unequally disadvantage the oldest retired members in passing Proposition C in 2011? If no—or ambiguous—did the SFERS Board have the legal authority to exercise its discretion to treat all SFERS retirees equally?

POB is still moving forward with our incorporation as a nonprofit organization. When our incorporation is completed we will be eligible to apply for a federal income tax exemption. We will keep you updated, as this is a rather lengthy process.

The Health Service System is still in

the selection process for a new HSS Director. It is our understanding that five candidates remain in the running. We are looking at Nov. 17 as a possible selection date. From the beginning, POB and RECCSF have both been involved in the process. We have submitted recommendations, and an outline of the set of skills and values an HSS director should possess that would be beneficial to our retirees.

RECCSF is holding its annual Health Fair on Oct. 11 at the Scottish Rite Temple, 19th Ave. at Sloat Blvd. Attending will be representatives from HSS, Kaiser, United Health Care, Vision Care, and Delta Dental. If you have concerns/questions you should attend; plus they will be giving out free flu shots for you and your dependents. On the SFERS Retirement Board front, the fossil fuel issue regarding divestment may be scheduled for the October SFERS meeting. As it will be at the call of the chair, we will have to wait until the agenda is set to confirm if the issue is listed for discussion or an action item.

POB contends that SFERS is a resource, and not an instrument for social or political change. To protect our pension system, SFERS trustees must be free from political meddling and intimidation. Many of our retirees depend upon their pension benefits for

security in their retirement years. POB believes SFERS trustees will do their due diligence regarding the question of divestment, and abide by their fiduciary responsibility to its beneficiaries in the process.

The battle goes on. POB voted unanimously to file an amicus brief with the court of appeals on behalf of our pre-1996 retirees. It is our position that there is only “all retirees,” not “pre-and-post 1996” retirees. (That language is not in the city charter.)

POB is reorganizing, and funds are holding steady—but we still need your help. Be sure to stay informed at [protectourbenefits.org](http://protectourbenefits.org) or Facebook. Your contributions are not tax deductible, but most appreciated. Please mail to P.O. 320057, San Francisco, Calif. 94132

# OPINION

Don't be fooled by the fear-mongering rhetoric about our pensions going down the drain if the SFERS divests its fossil fuel investments. Believe your own eyes and ears, not what is told to you by people relying on some "study" or other funded by the oil, gas, and coal companies.

An analysis by MSCI, an independent company that provides research-driven insights and tools for institutional investors—including those that wish to divest from fossil fuels—has developed world-wide fossil fuel free indexes that earn more than conventional indexes. Simply put, the MSCI index provides a path for SFERS, and other institutions, to have a better rate of return on their investment portfolios without fossil fuels.

SFERS has the fiduciary duty to minimize risk and maximize rate of return. We retirees should demand that the SFERS get a better rate of return by conforming its investments to the MSCI fossil fuel free indexes.

I see no upside for the ERS Fund if we walk away from all fossil fuel investments. Electric is clean and desirable, but turbines fire up every day with fossil fuels. If all cars were electric tomorrow, charging stations off the electric grid would still be powered by fossil fuels. Draining the grid would create rolling blackouts and shortages, which would have an adverse financial impact to our industries and a negative effect on our way of life. Right now, this is how we live—dependent on fossil fuels. And climate change is occurring, as it always has throughout history.

The ERS Board exists to research, debate and determine the best financial investments to grow our fund and protect it from radical declines. It should not be a vehicle for social lobby groups to promote the policies of politicians and their proponents. Please keep politics out of the decisions that are financially advantageous for the fund.
